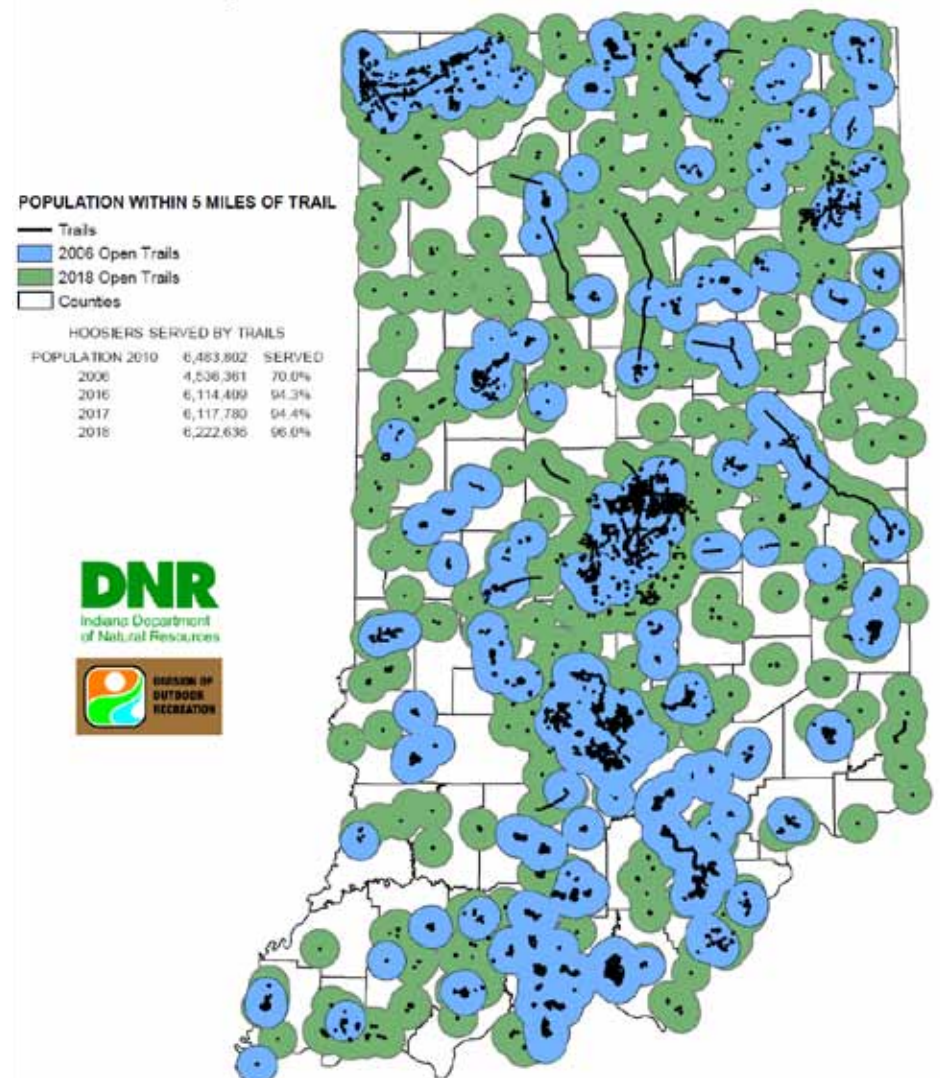
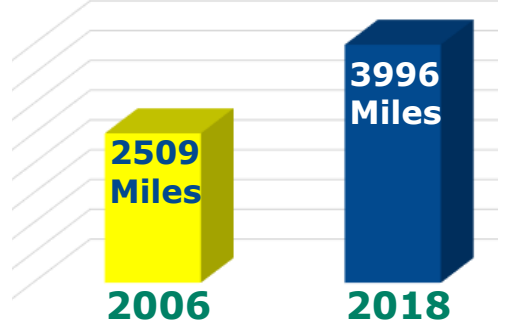

 - Providing startup grants to help local trails organizations build capacity and support
 - Acting as a source of trails information and consultation to local Indiana governments
 - Promoting best practices in the planning, marketing, design, development, and management of linear parks

We promote all types of trails, whether they are for bikers, walkers, horseback riders, ATVs or paddling canoes and kayaks down the waterways. We are proud of the many partners and friends we have made along the way!

The Greenways Foundation, Inc. is an Indiana nonprofit corporation, classified as a 501(c)(3) public charitable trust under IRS regulations. This means that contributions can be charitable tax deductions to qualified individuals who itemize deductions on their federal income tax return.

2018 Highlights

NextLevel Connections

The Greenways Foundation presented our **2019 Legislative Platform** with the help of Indiana trail stakeholders. We continue to work with state legislators on funding the existing trails maintenance fund, and sustainable funding for new trails when the Next Level Trails program is complete. The demand for trails in Indiana is strong!



In 2018, Governor Holcomb earmarked **\$90 million** for new trails statewide through the Next Level Trails program. The Foundation has been leading the charge for new fund sources to grow our popular trail network.

We proudly sponsored the 2018 Greenways+Blueways Map in Northwest Indiana. We have served as a sponsor for this excellent resource since the first map was published in 2008. We understand the importance of marketing, and can help you with getting the word out about your trail too!



Our **state license plate** accounts for our main source of revenue. At the end of 2018 there were **1446 plates** sold for a total income of **\$36,150**. Those who buy plates become new members of the Foundation.



Thanks to our state plates, we were able to **award \$21,000 in grants** to five trail projects in 2018! These include...

\$5,000 to Noble Trails to aid with the extension of the Fishing Line Trail between Rome City and Kendallville



\$1,000 to the Friends of the Quaker Trace Trail for start-up costs to secure federal nonprofit status

\$5,000 to aid the Indianapolis Parks Foundation in repairing a bridge on the Pogues Run Trail



\$5,000 to Prairie Trails Club to aid with the expansion of the Erie Trail

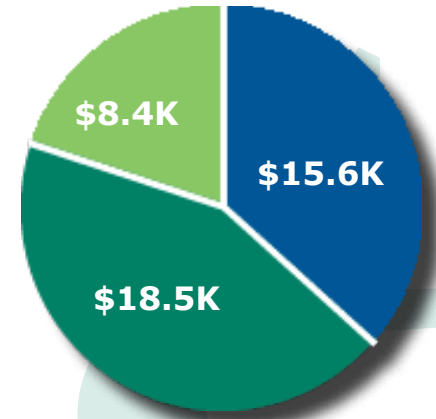
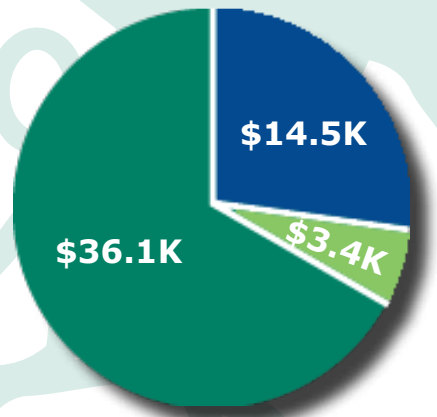
\$5,000 to South Adams Trails to aid with the installation of two historic bridges for trail use between Berne and Geneva

2018 Inflows \$54K

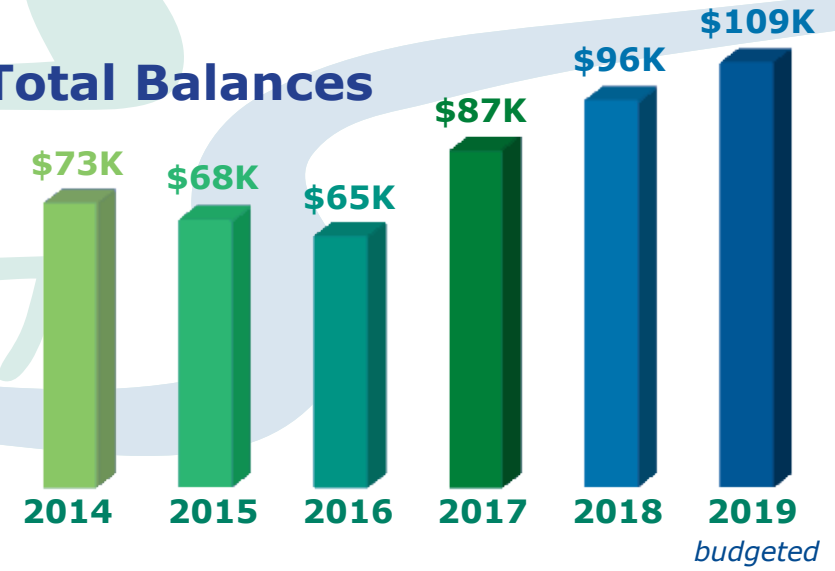
License Plates 67%
